3. Subject to the reporting person's continuous service through the vesting date, 100% of the RSUs shall vest on January 1, 2026.

4. On February 27, 2023, the reporting person was granted 2,020 Performance Share Units ("PSUs"). Each PSU is equivalent to one share of the Company's common stock. The number of units subject to vest under this award can range from 0% to 150% of the amount shown based on the satisfaction of performance condition targets during the requisite service period. This award fully vests on January 1, 2026.
