Explanation of Responses:

- 1. The reporting person was granted 3,858 shares of Restricted Stock on December 31, 2020, as a match to shares purchased under the 2016 Employee Incentive Program. The award is subject to three-year ratable vesting. The first tranche vested on April 16, 2021. The second tranche vested on April 16, 2022. The third and final tranche will immediately vest upon the consummation of the Company's IPO.
- 2. On January 1, 2022, the reporting person was granted a Restricted Stock Award in the amount of 2,532 shares. Each share is equivalent to one share of the Company's common stock. This award fully vests on January 1, 2025.
- 3. On January 1, 2021, the reporting person was granted 1,394 Restricted Stock Units ("RSUs"). Upon vesting, each unit is equivalent to one share of the Company's common stock. This award fully vests on January 1, 2024.
- 4. On November 5, 2021, the reporting person was granted 3,968 RSUs. Upon vesting, each unit is equivalent to one share of the Company's common stock. This award fully vests on January 1, 2024.
- 5. On January 1, 2022, the reporting person was awarded 2,532 Performance Share Units ("PSUs"). Each PSU is equivalent to one share of the Company's common stock. The number of units subject to vest under this award can range from 0% to 150% of the amount shown based on the satisfaction of performance condition targets during the requisite service period. This award fully vests on January 1, 2025.
