#### **Explanation of Responses:**

- 2. On January 1, 2022, the reporting person was granted a Restricted Stock Award in the amount of 22,796 shares. Each share is equivalent to one share of the Company's common stock. This award fully vests on January 1, 2025.
- 3. On January 1, 2021, the reporting person was granted 40,137 Restricted Stock Units ("RSUs"). Upon vesting, each unit is equivalent to one share of the Company's common stock. This award fully vests on January 1, 2024.
- 4. On January 1, 2021, the reporting person was granted 40,137 Performance Share Units ("PSUs"). Each PSU is equivalent to one share of the Company's common stock. The number of units subject to vest under this award can range from 0% to 150% of the amount shown based on the satisfaction of performance condition targets during the requisite service period. This award will fully vest on January 1, 2024.
- 5. On January 1, 2022, the reporting person was granted 22,796 PSUs. Each PSU is equivalent to one share of the Company's common stock. The number of units subject to vest under this award can range from 0% to 150% of the amount shown based on the satisfaction of performance condition targets during the requisite service period. This award will fully vest on January 1, 2025.
